By submitting an application for the Conservation Volunteers International Program (“ConservationVIP®”) 2025 Yosemite Scholarship (the “Scholarship”), all applicants represent that they are over the age of 18 and that they have read and agree to the following Term and Conditions:

1. Eligibility

This ConservationVIP® 2025 Yosemite Scholarship is open to U.S. residents, 18-29 years old. All applicants must follow the application procedures and be in physical condition to perform strenuous outdoor activities. This promotion is void where prohibited by law. By participating, you agree to be fully unconditionally bound by these Terms and Conditions, and you represent and warrant that you meet the eligibility requirements.

2. How to enter

Visit <https://conservationvip.org/scholarship/> to read the rules and apply for the Scholarship. The entry must fulfill all Scholarship requirements, as specified. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of ConservationVIP®. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of ConservationVIP®.

The 2025 Yosemite Scholarship will begin accepting applications on June 20, 2025. The application deadline is July 11, 2025, at 11:59pm PST. The winner(s) will be announced on or about July 14, 2025. ConservationVIP® may adjust or extend the promotion period at its sole discretion. Odds of winning will depend on the number of people who apply for this Scholarship. Limit one entry per person. All entries submitted become the sole property of ConservationVIP® and will not be returned. 4. Selection of Scholarship Recipients

The selection of scholarship recipients will be conducted by a panel of judges designated by ConservationVIP® and will be based on the quality of the application, including the video submission. Scholarship recipients will be selected in accordance with the schedule set out above. There will be up to 2 scholarship recipients chosen. All decisions are final.

5. Prize

Scholarship recipients will receive one space on ConservationVIP's [September 2025 Yosemite Volunteer Trip](#) (a \$1,095 value). The scholarship prize is only applicable to the September 2025 Yosemite Volunteer Trip and not applicable for any future volunteer trip. Scholarship includes: entrance to the park, campground reservations, all meals from dinner on Day 1 through breakfast on Day 7, project leadership and support staff, group tools, transportation to and from the campground and volunteer project sites, orientation and training. You will be responsible for transportation to/from Yosemite National Park, camping gear (you must bring your own tent, sleeping bag and sleeping pad), the cost of medical immunizations, insurance (emergency medical and evacuation insurance is mandatory for this trip), airline excess baggage charges, airport taxes, alcoholic beverages (if over 21 years old) or soft drinks, gratuities and personal items, and any other expenses. All scholarship recipients must complete the 2025 Yosemite Volunteer Trip Booking Application which includes a Release and Agreement. ConservationVIP® reserves the right to disqualify any recipient prior to the trip if in ConservationVIP's sole discretion, their participation on the trip would no longer be appropriate. Please note, you are also responsible for obtaining your own travel documentation, including but not limited to a passport or REAL ID. No cash or other prize substitution shall be permitted except at ConservationVIP's discretion. The scholarship is nontransferable. Any and all scholarship-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the scholarship recipient. Acceptance of the scholarship constitutes permission for ConservationVIP® to use your name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
